

- 1) Coercing Australian citizens to take an experimental medication was a clear infringement of the Nuremberg Code¹:
 - **The voluntary consent of the human subject is absolutely essential.** This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of **force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion;** and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision.
- 2) That the mRNA Covid vaccines were experimental² is becoming more and more abundantly clear. The mRNA transcription process skips over the Methyl-1-Pseudouridine and creates random proteins³, a process that could create harmful prions, the agents of Alzheimer's and Parkinson's disease. There were fragments of DNA in the RNA in the injection and these fragments included SV-40, a cancer-causing agent⁴.
- 3) The Covid Vaccines were only approved by the FDA under Emergency Use Approval (EUA) - the TGA page saying approval was not rushed (which has since disappeared from the internet) contained a clear lie, because Provisional Approval is essentially the same as EUA⁵.
- 4) Note that even if someone took the AstraZeneca vaccine (which was later removed for safety issues) they would still have had to take an mRNA booster.
- 5) Prime Minister Scott Morrison and the Federal Government clearly approved of and enabled the policy of coercing Australians to take the Covid vaccinations by threatening them with loss of jobs ("no job no pay" and "as mandatory as possible") a policy which was recommended by the

AHPPC⁶ and Scott Morrison and put into force by State Governments⁷ - in October 2021 the Cabinet discussed employment mandates but did not follow through.

- 6) Nonetheless it is arguable that the Federal Government had a duty to stop the states from infringing the Australian Constitution: medical conscription is clearly not allowed. The Constitution disallows ‘medical conscription’ in Section 51 (xxiiiA); in the High Court in 1949 it was decided this means no medical coercion is allowed *by direct or indirect means*.
- 7) By warning Doctors in March 2021 they would be deregistered if they questioned Covid vaccines⁸ the Federally legislated body AHPRA infringed on patient rights to informed consent with regard to Covid vaccination. This was a serious breach of the Nuremberg Code as well, especially considering the large number of disabilities and deaths that resulted⁹ and the likelihood that Australian excess deaths in 2022 and 2023 were related to Covid vaccination¹⁰.
- 8) The TGA approval process for the Covid vaccine was, quite frankly, abysmally inadequate. The only document examined by the TGA for approval of the Pfizer vaccines was a sloppy document that still had track changes enabled, and that demonstrated that the Lipid Nanoparticles of the Pfizer vaccines did not stay at the injection site in rats, but spread throughout the body, particularly to the ovaries. The track changes revealed their indecision concerning the safety of the vaccine with regard to

- 9) In the past it has taken more than one inquiry / Royal Commission to get to the facts¹². I hope those conducting this inquiry will honestly look at the evidence that wrong was done, for the sake of their own future reputations, and, indeed, for the sake of their own immortal souls (Mark 8:36).
